# Notes:

- 1) Welcome: Introduction / Roll Call of Officers and Regional Directors (Amy Trang)
  - a) Members were asked to introduce themselves in the chat box
  - b) Recognize any new members on the call:
    - i) Dr. Vivian Huang, MD, Regional Medical Director, Dynavax (not new to the Task Force, but has a new job position)
    - ii) Maggie Li, Program Coordinator, Midwest Asian Health Association (MAHA) in Chicago, IL
    - iii) Vivian Ching, CPACS (Atlanta, GA)
    - iv) Alondra M., Health Program Specialist for Perinatal Hepatitis B Prevention Program with San Antonio Metro Health (Texas)
  - c) Opening remarks made by Richard So and Catherine Freeland.

- 3) Website Discussion (Amy Trang)
  - a) We had a working session to discuss and outline what the website should look like.
  - b) See notes and DRAFT web content outline at the end of the meeting notes.
  - c) The website should be like a "clearinghouse" for resources to share.
  - d) Progress of the website (screenshots) will be shared with members along the way since we don't have a meeting until September.

- 4) Hepatitis B ECHO Updates (Richard So and Catherine Freeland)
  - a) West Coast hepatitis B ECHO Hub
    - i) The program is progressing strong with average of 30 participants each session.
    - ii) Adjustments and tweaks to the program delivery have been made each month to fit the needs of participants, especially when reviewing case studies.
    - iii) Regular participants are encouraged to share cases and have priority to present their cases at the monthly session.
    - iv) This is a program that SF Hep B Free intends to keep long-term and is actively seeking funds to sustain beyond the project year that ends in September.
  - b) East Coast hepatitis B ECHO Hub
    - i) The program is about halfway through its 12-month program period.
    - ii) The organizing committee will be meeting in August to evaluate the program and discuss sustainability. Hepatitis B Foundation is committed to seeing this program be successful long-term.
    - iii) So far, there's been a strong group of engaged participants.
    - iv) Looking ahead for next year, we're welcoming additional experts who may be interested in joining the panel to alleviate schedule conflicts and other commitments among our team of experts.
  - c) Updates on initiatives in Texas
    - i) Dr. Stephen Fakoyejo and Dr. Richard Andrews have been looking into recruiting individuals who may be interested in participating in a hepatitis B ECHO program in Texas that would be led by Baylor University. There were some delays because Dr. Andrews has been transitioning into his new position at a methadone clinic. They will be refocusing to recruit again and reach out to Baylor on when to start the pilot session.
  - d) Question(s) from Dr. Lu-yu Hwang regarding the ECHO program model: Is there a required cost (obligation) in using special equipment to set-up an ECHO program? Since there's been a lot of virtual trainings and meetings during the pandemic, what differentiates an ECHO program with other virtual meetings?
    - i) There is not a required cost in setting-up an ECHO program, but there is a required training to learn how to successfully start an ECHO program.     - ii) What differentiates an ECHO program with other virtual meetings is understanding the ECHO model. ECHO sessions are designed around case-based learning and mentorship. The intention is to create a sustainable learning community, not just an information session. More information can be found here: <a href="https://hsc.unm.edu/echo/get-involved">https://hsc.unm.edu/echo/get-involved</a>.
    - iii) There's a format for the ECHO sessions and CMEs can be offered.
    - iv) There is no required special infrastructure or equipment to set-up an ECHO program.
- 5) Regional Directors' Updates
  - a) Western Region (Thaddeus Pham):
    - i) In Hawaii, we'll be working with legislative champions to recognize World Hepatitis Day in July. There were hepatitis awareness activities throughout the month of May (and shared via social media).
    - ii) In California, Dr. Sam So shared via email that the hepatitis B and C screening and linkage to care bill has passed the CA state assembly. He sends his appreciation to task force members who have summited letters to support the bill.
      - (1) Health committee with a vote of 15-0
      - (2) Appropriations committee with a vote of 16-0
      - (3) Assembly floor with a vote of 78-0

- (4) The bill will be heard by the state senate health committee and judiciary committee within the next two weeks
- (5) Amy and Thaddeus noted that this has served as a model for other states; Thaddeus is looking into doing something similar in Hawaii.
- iii) In San Diego, Dr. Binh Tran wants to recognize Dr. Richard Andrews for "joining" APHF and providing a presentation to members and students as well as being a resource for them.
- iv) In San Francisco, Richard So shared that:
  - (1) they have had some success in working with some of the tech companies to encourage their staff to get screened and tested for hepatitis B. It was a joint effort with some of the other Asian American advocacy groups. This is a new venue for SF Hep B Free and their looking forward to a positive collaboration.
  - (2) They have also been reaching out to some small businesses that are owned by AAPI to have a chance to talk to the owners, employees, and their customers.
  - (3) There was a lunch and learn event for life sciences companies that put out hepatitis B or liver cancer products; they brought a patient speaker to the event; it was a morale boost for the company's employee as well as a small donation for the organization.
  - (4) SF Hep B Free is also soon embarking on strategic planning and will keep everyone updated on their progress and results.
- b) Southeast Region (Christina Meyers): No new updates this month.
- c) Mid-Atlantic Region (Kate Lu via email): No new updates this month.
- d) Midwest Region (Dr. Oyu Tumurtuya via email): No new updates this month.
- e) South Midwest Region (Dr. Stephen Fakoyejo):
  - i) Will be working with Dr. Richard Andrews on recruiting for the hepatitis B ECHO program with Baylor University.
  - ii) Dr. Richard Andrews will be hosting a small informal discussion group tomorrow (June 23<sup>rd</sup>) on sub-Saharan hepatitis B health disparities. The discussion started as a small group in Houston, but is open to anyone who is interested in participating in the discussion. The intention was to discuss, find, and share resources for liver cancer prevention among the target population who may be at risk if they have hepatitis B or C infection(s). The link will be emailed to everyone who may be interested.
    - (1) Catherine mentioned that Hepatitis B Foundation also runs an African-focused coalition similar to HBU called CHIPO (<a href="https://www.hepb.org/research-and-programs/chipo/chipo-overview">https://www.hepb.org/research-and-programs/chipo/chipo-overview</a>).
- f) Northeast Region (Ruth Brogden via email): No new updates this month.
- g) Student Representation (Sandra Kong):
  - i) Will be following up with students from Team HBV and APAMSA on their workforce development interest and needs; last month was "finals" so it was not a good time to engage students.
  - ii) Team HBV helped the Task Force with social media activities in May for Hepatitis Awareness Month.

## 6) Other items:

- a) Any updates from Dynavax for the vaccination campaign proposal?
  - i) Dr. Carol Brosgart previously shared via email with Amy that the proposal is still being considered for funding.
- b) July 28th is World Hepatitis Day.
  - i) The Task Force will promote activities and events shared by members throughout the month of July.
- c) ACIP meeting update
  - i) Dr. Carol Brosgart and Dr. Vivian Huang helped clarify that the universal adult vaccination for hepatitis B is not on the agenda for discussion this week (June 23 -25). It was originally on the schedule for discussion, but June 19<sup>th</sup> was a holiday so there were other items that have been pushed back for this week's meeting.
  - ii) The hepatitis B universal vaccination session is rescheduled to be heard at the August meeting. Safety data and recommendation process will be discussed. Recommendations will be made in October.

- iii) Dr. Brosgart reminded everyone that the Task Force's position is still in support of screening, testing, and diagnosing first before hepatitis B vaccination. Amy added that this was the consensus from many past Hep B Task Force meetings and discussions by members (the majority being primary care providers on the Task Force).
