Upcoming Events and Initiatives @ 0:00

The group discussed several upcoming events and initiatives for World Hepatitis Day on July 28th, including:

Restructuring the National Task Force @ 25:00

The group discussed the future structure and governance of the National Task Force on Hepatitis B. There was consensus to move away from a formal elected governing board structure, and instead have a more informal, volunteer-based coalition focused on specific projects and initiatives. The group agreed to maintain regular meetings, but with a flexible format that accommodates the busy schedules of the clinical members. Any funds or grants received will be overseen by a committee, but the group will otherwise operate in a grassroots, collaborative manner.

Global Hepatitis Efforts and Partnerships @ 35:00

The group discussed the importance of taking a global perspective on hepatitis elimination, and highlighted several international initiatives and guidelines that the task force should be aware of and potentially help disseminate, such as the new WHO guidelines on mother-to-child hepatitis B transmission. There was emphasis on the need to support efforts in low-resource countries, as well as engage diaspora communities in the US who may have originated from high-burden regions. The group agreed to continue leveraging partnerships with organizations like the Hepatitis B Foundation to coordinate global efforts.

Recap and Next Steps @ 1:05:00

The meeting concluded with a recap of the key discussion points and action items, including:

- Promoting the upcoming events and initiatives on the task force website
- Exploring research on hepatitis B and TB co-morbidity
- Maintaining the informal, collaborative structure of the task force moving forward
